

## **FY28 Proposed Budget Detail Report**

This document provides additional information related to staff recommendations for the Alaska Mental Health Trust Authority's FY28 budget. It is intended to serve as a supplemental tool to support the Trustee's consideration and approval of the FY28 spending in support of Trust beneficiaries. Content is organized by budget section and placed in the same order as the content in the draft budget spreadsheet.

The budget is broken out into two sections: Mental Health Trust Authority Authorized Receipts (MHTAAR) grant-funded projects to state agencies, and Authority Grant (AG) funded projects. Within those sections, increments are organized by Trust priority areas identified in the Trust Strategic Plan adopted in late 2025.

### MHTAAR Funding and GF/MH Recommendations

Alaska consistently has suicide rates well above the national average. An SFR would enable Alaska to systemically investigate suicide deaths, emphasize local risk and protective factors, and drive targeted interventions. Alaska already has a maternal and child death review process and an overdose fatality review in place. Extending these models to suicide builds upon existing frameworks, expertise, data systems, and cross-agency partnerships to drive scalable public health outcomes. FY28 is the first year of Trust funding; multi-year support (3-5 years) is anticipated to successfully onboard this new project.

This is a data capacity building and maintenance project. The work has emphasized a broad definition of health care to include behavioral health and home and community-based services occupations. Over the past 20 years this funding has supported statewide data collection of key healthcare and beneficiary-related workforce availability issues that have included workforce vacancy studies, difficult to recruit positions, and stability. This resource has recently supported behavioral health workforce initiatives at the University of Alaska, the Alaska Dementia Action Collaborative, and is currently working with Trust staff to develop population projects for Trust beneficiary-related categories.

Continued funding is necessary to have access to data and analytic capacity to support and allow the Trust to forecast and plan for addressing the needs and improving the circumstances of beneficiaries and ensuring beneficiary access to a complete continuum of care.

AKTC directly advances the Comprehensive Integrated Mental Health Program Plan (Strengthening the System II: 2025-2029) by expanding evidence-based, culturally responsive workforce development opportunities critical to beneficiary outcomes.

This project advances the Trust’s workforce development goals by increasing supervisory capacity within Alaska school districts—an essential requirement for preparing and retaining school psychologists. Many rural districts employ no school psychologists who are qualified to supervise students, creating a significant barrier to licensure and limiting the statewide workforce pipeline. Project COMPASS supports both responsive needs (expanding supervisory availability where gaps exist) and Trust-initiated efforts to strengthen a critical behavioral health workforce strategy.

This is a new FY28 request that builds on prior Trust investments, including the FY26 MHTAAR-funded community of practice. The program’s three objectives—continuing the statewide community of practice, enhancing supervisory skills through structured professional development, and increasing distance supervision options for rural districts—are expected to directly improve access to clinical placements, strengthen the workforce pipeline, and expand the availability of school psychologists statewide.

This is a proposed 2-year pilot, with funds also recommended for FY29. Because the purpose is to build capacity and address a specific workforce gap, future funding is not anticipated.

In FY26, ACBHC received 30 new peer certification applications and issued 38 certifications, including Tribal Peer Support Specialist credentials. Continued Trust funding is recommended as DBH works to further build certification infrastructure and expand the workforce statewide.

### Staff Analysis

Home modifications increase the accessibility of current housing so that Trust beneficiaries can move into or remain in their own homes when they acquire a physical disability. Home modifications are available to people wherever they reside, regardless of whether they own or rent and with whom they live. Typical kinds of assistance provided are accessibility modifications or additions (e.g., widening doorways, remodeling bathrooms and/or kitchens, installing entrance ramps, and related equipment.) All funds are awarded through a statewide competitive grant process to qualified organizations. An average of 20-30 people receive home modifications through this grant annually. The Trust no longer supports this grant with MHTAAR funding, as FY23 was the final year of Trust funding after 21 years of support. The project has now transitioned to a GF/MH recommendation that still needs advocacy.

### Authority Grant Funding

The mini-grant program is a long-standing Trust investment that fills small gaps in services or meets other needs of Trust beneficiaries with items or services needed to maintain their quality of life and increase independent functioning. Individual mini-grants are awarded to a community organization that applies on behalf of the beneficiary. Applications for mini-grants are reviewed each month by an evaluation committee consisting of representatives from the Trust and the appropriate statutory advisory boards(s). Mini-grants provide a direct service to individual beneficiaries through assistance in securing needed items or services not covered by other funding sources. The primary challenge for the mini-grant program has been the capacity of community organizations to apply for and administer the grants on behalf of the beneficiaries they work with. These organizations provide crucial services but frequently have demands that exceed their capacity.

#### FY25 Trust Mini Grant Award Information

In FY25, 874 Behavioral Health and Intellectual and Developmental Disabilities mini-grants were awarded, totaling \$1,270,956. Of the \$1,270,956 awarded, the program's actual grant disbursements were \$1,144,720. The difference between the awarded and disbursed amounts is due to approved grants sometimes not being spent because of changing circumstances experienced by individual beneficiaries. For FY25, the administrative costs for the contractor to administer the program were \$233,600, or 15.6% of the total mini-grant program budget line.

Technical assistance can be provided in six key areas: planning, governance and operations; monitoring and evaluation, growth, stabilization, and reduction; financial management; technology solutions; and facility-based project planning. A competitive RFP is issued to determine the contractors for the project. Contractors that meet the criteria are added to a pool from which the agency and Program Officer can select based on the presenting need and contractor specialty. Contracts will be utilized on an as-needed basis and there is no guarantee of work. Contractors will be selected for specified projects based on qualifications, expertise, and other considerations including fit with an organization.

#### Staff Analysis

This contract assists beneficiary serving organizations to improve operations and make key business or programmatic decisions and was developed to respond quickly to the emerging needs of beneficiary-serving organizations. Technical Assistance can also be requested to accompany a grant to set the project up for success, especially for complex projects, or when an organization's project is not quite ready to fund to help prepare the organization for the project or remediate a concern. Strategic planning and business plans are common requests for these situations. Projects are referred by program officers and alignment with priority area initiatives are prioritized. Technical assistance categories were selected through a review of past requests and projects, surveys with contractors and agencies that have used the contract, and meetings with the Program Team.

In FY25, 29 projects were requested, and 19 moved forward with a scope of work. Six projects were in Anchorage, three in Southeast Alaska, one in Kenai, two in Southcentral Alaska, and seven statewide. The average project cost was \$21,844, with a low of \$5,610 and a high of \$50,000. The average length of a project was six and a half months. The most frequent project requests were service sustainability/feasibility (8) and financial review/planning (5). Technical Assistance Contract trends include longer project periods, an increase in no-cost extensions, and an organization needing multiple types of assistance (if the budget allows). This is expected to be an annual funding request, based on project performance and Trustee approval.

## **FY28 Budget Line Briefs**

### **Authority Grant Funding**

Six interns completed the program in FY25, and a total of 139 have finished the program since its inception 15 years ago. 48% of the interns took their first job upon graduation in Alaska, with 86% still working and residing in the state. Trust funds pay WICHE staff to facilitate the program and evaluation necessary to maintain its APA accreditation, as well as support travel and academic instruction in the rural sites. The other significant outcome of this program is the clinical provision hours provided by the interns to beneficiaries in rural Alaska, which range between 500 and 600 per year of their internship. It is anticipated that Trust funding will be required to sustain the program through the next 2-4 years, while our partners work to bring on other funding sources.
